#### **Duties & Responsibilities**

#### (A) General Definition of Vice Chancellor of a University

The Vice Chancellor (VC) is the highest-ranking executive and academic officer in a university. They provide leadership, vision, and overall management of the institution, shaping its strategic direction, academic policies, and success.

#### (B) Main Duties and Responsibilities of the Vice Chancellor (VC) of CIU:

- 6. Enhance student experience through student services and welfare programs.
- 7. Promote and support research activities, innovation, and collaborations.
- 8. Represent the university to external stakeholders and foster partnerships.
- 9. Ensure compliance with accreditation standards and quality assurance.
- 10. Engage in fundraising efforts and cultivate relationships with donors.
- 11. Foster community engagement and address societal needs.
- 12. Develop strategies for international collaborations and attracting international students.
- 13. Plan and oversee campus development and infrastructure projects.
- 14. Establish and review policies to ensure compliance with regulations.
- 15. Lead the university during crises or emergencies.
- 16. Maintain and enhance relationships with alumni for support and involvement.
- 17. Ensure academic quality through program reviews and assessments.
- 18. Manage public relations and media interactions.
- 19. Foster collaborations with other universities and organizations.
- 20. Drive continuous improvement of university operations and programs.

#### (C) <u>Detailed Execution of Duties & Responsibilities:</u>

#### 1. Developing and communicating a clear vision and strategic plan for CIU in consultation with key stakeholders:
